The Metropolitan Museum of Art – Tang Wing

CEQR No. 25DPR007M

Project area: Upper East Side, Manhattan Community Districts #5, 7, 8, 10, 11

In accordance with Executive Order 91 of 1977, as amended, and the Rules of Procedure for City Environmental Quality Review, found at Title 62, Chapter 5 (CEQR) and the State Environmental Quality Review Act (SEQRA) and its implementing regulations as set forth in 6 NYCRR Part 617, the New York City Department of Parks and Recreation (NYC Parks) proposes to assume the role of lead agency for the environmental review of the project as described below.

The assumption of lead agency status is consistent with the underlying mandate of CEQR that the appropriate lead agency should be the agency "primarily responsible for carrying out, funding or approving an action," as well as with the criteria listed in Sections 5-03 (h) and 5-05 of the Rules of Procedure for CEQR. The affected property is park land under the control or jurisdiction of NYC Parks.

NYC Parks is conducting a coordinated environmental review for the proposed project. Your agency has been identified as a potentially involved or interested agency for the review and approval of the proposed action. If you have questions or issues concerning this agency's assuming lead agency status for this project, please contact us by Wednesday, March 26, 2025. If we do not hear from you by this time, we will assume that you have no objections.

Project Description:

The Metropolitan Museum of Art (the Met or the Museum) is seeking discretionary actions in connection with the proposed replacement of one wing in the Museum's existing building complex on Fifth Avenue in Manhattan, within Central Park. The Met has prepared Parts 1 and 2 of the Environmental Assessment Form (EAF). Per 6 N.Y.C.R.R. § 617.6(b)(3)(i), a copy of that document is enclosed with this letter.

According to the EAF, the proposed Oscar L. Tang and H.M. Agnes Hsu-Tang Wing (the Tang Wing) for Modern and Contemporary Art would be a five-story, approximately 163,100 gross square foot (gsf) structure (approximately 124,900 gsf above grade) integrated into the southwest corner of the Museum's existing building complex, replacing the existing Lila Acheson Wallace (LAW) Wing at this location. According to the EAF, the Tang Wing would replace the existing deteriorating building envelope of the

LAW Wing and provide the Met with appropriately scaled gallery space designed for exhibiting modern and contemporary art of different scales, forms, and themes while also establishing physical and visual connections to nearby galleries. According to the EAF, the proposed project would provide for improved accessibility for visitors of all abilities throughout the Tang Wing and would remediate significant sustainability challenges resulting from the design of the LAW Wing. According to the EAF, the LAW Wing is 180,400 gsf (123,100 gsf above grade), while the Tang Wing is planned to be approximately 163,100 gsf (124,900 gsf above grade), resulting in an addition of approximately 1,800 gsf above grade. Landscape reconstruction and improvements would be made in the approximately 144,850 sf area of Central Park surrounding the Tang Wing.

The proposed discretionary actions required to facilitate the proposed project that are subject to CEQR are currently anticipated to consist of approval by NYC Parks and authorization of potential funding by the New York City Department of Cultural Affairs (DCLA). The proposed project would also include various ministerial actions, including approval and a report from the New York City Landmarks Preservation Commission (LPC), as well as design approval of the landscape restoration and improvements by the New York City Public Design Commission (PDC).
